NO EXCEPTIONS.

No more than 3 people in line at a time during weigh-in. All fish are released after weigh-in. Anytime the big engine is in use, life jackets must be worn. You must stay 50 yards from a boat that is anchored with a trolling motor out of the water.

New 2018 Tournament Regulations will be addressed at the meeting before take-off. In the event of a tie, the choice is given to split the money or flip a coin. Protests must be stated verbally to the person(s) in charge prior to the pay-out. Tournament officials will decide any discrepancies. Weigh before you load your boat!!! Anyone caught violating the above rules or cheating will be disqualified.
